Hi, I'm Barry Blundell. I share some of the most meaningful and joyful times in people's lives. I feel a real sense of accomplishment when assisting my customers in the planning of their "very personal" ceremonies, especially when they realise that their vision for their very special day is very achievable, just the way they may want it to be!

I have been a registered Commonwealth Civil Marriage Celebrant since January 2009 and as such, I am able to solemnise marriages across all States and Territories of Australia.

I am the 'Ask A Celebrant' Gold Rose Promotion Celebrant for the Riverina Highlands and Riverina Regions again for 2017-2018! This annual promotion offers my customers an opportunity to win a variety of cash prizes, but of course conditions do apply. *(Check with us!)*

I am a member of two Celebrant associations; the 'Riverina Marriage Celebrants Association Inc.' (RMCA), and the 'Civil Celebrations Network Inc' (CCN Inc.). These organisations assist me in keeping up to date with changes of Government Policy in regards to the Australian Marriage Act 1961; to which all Marriage Celebrants both Civil and Religious, must comply.

I am also a New South Wales Justice of the Peace having first been appointed in 1989 and as such I am available to certify copies of documents, administer Oaths, Affirmations, Affidavits and Statutory Declarations as required for the State of NSW in addition to those of the Commonwealth. Justice of the Peace services are provided free of charge but a pre-arranged appointment is a requirement if I am to assist you in a timely fashion.

What can you expect from me for your ceremony?

I look forward to being able to assist you in creating a *'Heavenly Ceremony Of Your Own Design'* that will reflect your cultural background, personalities, values and dreams; a ceremony so, so very special that you, your family and your friends will remember

All items listed are inclusive of our Base Fee for each ceremony.

- On initial contact I will arrange a meeting appointment with you. If that is not possible due to distance, further communications can be carried out via Email, Facebook-chat, Messenger, Telephone or even Skype-Chat or Skype-Audio;
- Initial obligation-free interview at my home or a mutually convenient venue;
- Interviews, unlimited telephone and email contact with you to discuss every aspect of planning your ceremony;
- The sighting of all relevant, original documents as appropriate;
- Recommendations to other local businesses associated within the celebrancy industry, if requested;
- My assistance with ceremony planning such as themes, involvement of others, music, readings and poetry etc;
- All meetings conducted up to the date of the ceremony;
- Emailed draft copies (*pdfs*) of your ceremony for you to check;
- A generous, FREE Travel Allowance is inclusive with ALL ceremonies;
- If a wedding; a rehearsal is always and highly recommended with the final draft of your ceremony, but may incur additional travel costs depending on the distance I need to travel to your venue;
- I will arrive at the venue at least thirty minutes before the due start time of your ceremony to setup and test any required equipment and also check the venue to ensure that all is in readiness for your ceremony;
- Presentation of printed certificates as required (*dependent on the type of ceremony chosen*);
- I can supply a register table with a white table cloth, one chair with or without a white satin cover, a desk set with pens for the signing of the Register and any other documentation (*as required*);

- I am also able to supply a portable Public Announcement System, Hand Held Microphone/s, BlueTooth /CD /USB/SD/MP3 Music Player with remote to assist in queuing your chosen music. These items of equipment are inclusive with our 'Uniquely Yours' and 'Short & Sweet' Wedding ceremonies, 'Renewal of Vows' and 'Commitment' ceremonies;
- Additional charges apply for PA, Microphones and MP3 Players etc requested for all other ceremonies; 'Elopement' & 'Legals Only' Weddings, 'Name-Givings', 'Engagements', 'Divorce' and 'Milestone' ceremonies; to name just a few;
- At the conclusion of your ceremony, you will receive an elegant, printed memento of your ceremony;
- Additional charges apply for the Hire of extra equipment eg Table/s, Table Cloths, Chair/s, Satin Chair Cover/s, Lectern for readings etc., for use during your ceremony.
